Question :

In response to Mr. Tommy CHEUNG, the Administration undertook to provide a flow chart setting out the mechanism and time frame for processing appeal cases for trade effluent surcharge (TES) rates and discharge factors for sewage charges and TES.

Reply :

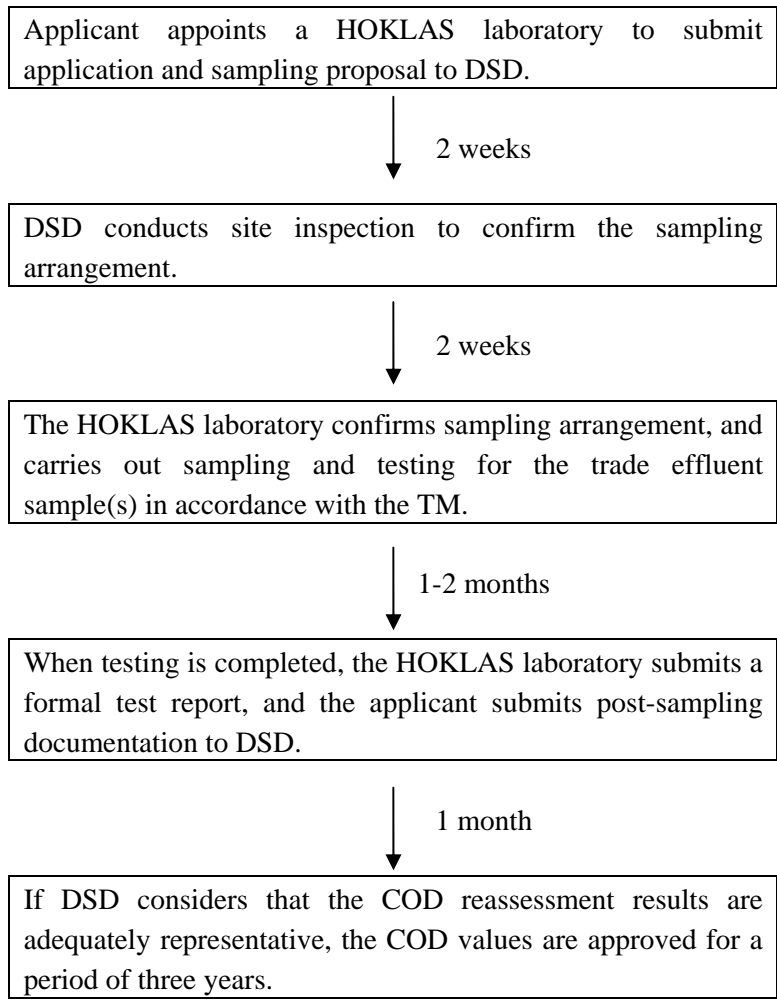
The mechanism and procedures of the application for reassessment of trade effluent surcharge (TES) rates and discharge factors for sewage charge and TES have been publicised and can be found in the website of the Drainage Services Department (DSD).

Procedures for assessing discharge factors for sewage charge and TES are relatively straight-forward and require the applicant to demonstrate that the volume of sewage discharged into the public sewerage system is not more than 85% of the chargeable volume of water. Upon receipt of all documental evidence and required information, six to eight weeks will be needed to process the application.

The procedures for TES rates reassessment include collecting and analysing representative samples of trade effluents, as detailed in the Technical Memorandum on Procedures and Methods for Sampling and Analysis of Trade Effluents (TM). They are summarised as follows -

- A TES payable consumer who is producing lower pollution strength effluent can apply for a Chemical Oxygen Demand (COD) reassessment for variation of the TES rate.
- The applicant should appoint an approved laboratory accredited under the Hong Kong Laboratory Accreditation Scheme (HOKLAS laboratory) to submit an application.
- Upon receipt of all required information, DSD will conduct site inspection to the concerned premises normally within two weeks to confirm the sampling arrangement and to verify the information submitted by the applicant.
- Sampling dates will be agreed amongst the applicant, the HOKLAS laboratory and DSD.
- Sampling conducted by the HOKLAS laboratory appointed by the applicant, depending on water consumption rates, will comprise two to six days of whole-day sample collection.
- During the course of sampling, DSD will inspect the site at any time to confirm that the agreed sampling protocol is being complied with, and that the trade activities and practices, including all pollution control measures affecting the effluent quality, are normal and strictly adhered to.
- When sampling is completed, the HOKLAS laboratory will carry out COD tests on the samples and submit a formal test report to DSD.

- DSD may conduct surprise ‘re-grab’ or ‘re-visit’ to verify whether the COD values submitted are sufficiently representative and to ensure that proper pollution control measures are adopted all the time during sampling.
- If DSD considers that the COD reassessment results are adequately representative, the COD values will be approved. If the approved COD values are lower than the generic values, a new TES rate will be derived from the COD values according to the charging matrix shown in Schedule D of the Sewage Services Ordinance (Cap. 463) and applied to the relevant TES account(s) for three years.

Question : Will the Administration construct dedicated LPG filling stations at the two new development zones, namely Kwu Tung and Hung Shui Kiu? If not, what are the reasons? The LPG vehicle trade has strongly requested for increase of dedicated LPG filling stations. If the Administration will not increase dedicated filling stations in the above-mentioned two new development zones, will there be any plan to increase dedicated LPG filling stations?

Reply :

At present, there are already a total of 12 dedicated and 50 petrol filling stations providing liquefied petroleum gas (LPG) filling services in Hong Kong, which can cater for the refilling needs of LPG taxis and light buses. To make refilling more convenient for LPG vehicles, the Government has a standing policy since 2000 to include the provision of LPG filling facilities in land sales requirement for petrol filling stations, subject to safety requirements being met, and has no plans to set up additional dedicated LPG filling stations. The new development areas at Kwu Tung and Hung Shui Kiu are still under planning. The Administration will consider providing petrol filling stations there, to which the afore-mentioned policy will apply.

Question : In respect of the recent stalling problem with travelling liquefied petroleum gas (LPG) taxis and light buses, please furnish the latest examination results so as to ensure the safety of passengers and drivers.

Reply :

With a view to ensuring liquefied petroleum gas (LPG) quality compliance, the Electrical and Mechanical Services Department (EMSD) has been conducting quality check on LPG since early January 2010. Up to end February 2011, EMSD has collected a total of 152 LPG samples directly from the LPG filling stations and LPG terminals for testing conducted by an accredited laboratory against the auto-LPG specification. So far, all test results show that LPG quality does not affect the performance of vehicles.

On top of the above-mentioned initiative, EMSD has also been vetting the independent third-party test reports submitted by LPG supply companies for each shipment to ensure that the quality of the imported LPG complies with the specified requirements.

EMSD has been maintaining a 24-hour hotline since January 2010 for drivers to report any stalling incident of LPG vehicles. Until 21 March 2011, the hotline received 195 calls on vehicle breakdown with most of the reports received in early 2010. From 1 January to 21 March 2011, the hotline only received four calls on vehicle breakdown. EMSD had inspected the four LPG taxis concerned and found that the vehicle breakdowns were not related to LPG quality but were caused by aged/failed vehicle parts or incorrect adjustment of air-fuel mix ratio, which were then referred to concerned vehicle owners and drivers to follow up.

Besides, what are the amount and percentage of recovered waste processed locally in the total amount of recovered waste? What are the amount and percentage of recovered waste that is immediately shipped overseas in the total amount of recovered waste?

Reply :

As mentioned in the reply to Question No. 0286, the amount of waste requiring disposal is dependent upon a number of factors including economic and population growth and construction activities, in addition to the recovery of waste for recycling. While the current recovery rate of municipal solid waste (MSW) was 49% in 2009, the Administration is working to strengthen measures to enhance community participation in waste reduction and recycling in order to reduce the amount of waste requiring disposal in 2011.

In 2009*, about 3.18 million tonnes of MSW were recovered in Hong Kong, out of which, about 0.03 million tonnes (or 0.9%) was recycled locally and about 3.15 million tonnes (or over 99%) were exported to places outside Hong Kong for recycling.

As part of our comprehensive waste management strategy announced in January 2011, the Government would expedite legislative proposals to introduce the new PRS on waste electrical and electronic equipment (WEEE). Amongst other things, the feasibility of landfill disposal ban would be considered in this context.

Preparation of the new PRS is being undertaken by the existing staff of the Environmental Protection Department as part of our normal duties and does not incur additional expenditure. We will report back to the Legislative Council Panel on Environmental Affairs on implementation proposal of the PRS on WEEE later this year.

Question : What is the percentage of rechargeable batteries recycled under voluntary schemes in the total amount? What are the reasons for not enforcing mandatory recycling? Would the Bureau consider the policy directions for introducing mandatory recycling?

Reply :

"Rechargeable Battery Recycling Programme" is a voluntary producer responsibility scheme (PRS) managed and funded by 36 battery manufacturers and importers. Since its inception in 2005, 249 tonnes (approximately 1 700 000 pieces) of rechargeable batteries have been collected under the recycling programme. At present, a significant portion of rechargeable batteries is used in mobile phones, digital cameras and other consumer electronic equipment. Used batteries are mostly sold to second hand dealers or channeled to them through trade-in as part of the equipment. Neither did our landfill survey capture any significant volume of rechargeable batteries. There is therefore not sufficient data to derive the recycling rate of rechargeable batteries.

In pursuing mandatory PRSs, our work priorities are to take forward the extension of the current scheme on plastic shopping bags and a new PRS on waste electrical and electronic equipment. Meanwhile, we are continuing with various voluntary programmes.

Experience sharing and liaison with officials of the Mainland and other countries on environmental protection, energy and related policies are an integral part of the responsibilities of Environment Bureau (ENB) and Environmental Protection Department (EPD).

Information related to the officials involved and the expenditure incurred in 2009-10 and 2010-11 on duty visits, exchanges, entertainment and meetings with Mainland and overseas officials are provided at the **Annex**.

In 2011-12, ENB and EPD have earmarked a provision of about \$2.2 million for duty visits, exchanges, and meetings in the Mainland and overseas countries. For the exchanges, entertainment and meetings with the Mainland and overseas officials and departments in Hong Kong, the provision is about \$0.3 million.
