Annual Work Report of the Energy Advisory Committee for the period from 1 January to 31 December 2014

I. <u>Terms of Reference of Energy Advisory Committee</u>

The Energy Advisory Committee (EnAC) is a non-statutory committee set up in July 1996 to advise the Government on energy policy, including policy matters concerning energy supply and demand, energy conservation and efficiency, and other related matters referred to it by the Government.

II. <u>Membership of EnAC</u>

EnAC is chaired by a non-official and comprises non-official members representing different sectors of the community and official members from relevant policy bureau and department. The Chairman and members are appointed by the Secretary for the Environment. The membership of EnAC in 2014 was as follows –

- III. <u>Major Activities of the EnAC during the period from 1 January to</u> <u>31 December 2014</u>
- (1) Meeting on 19 March 2014

Public Consultation on Future Fuel Mix for Electricity Generation in Hong Kong

Members were briefed on the three-month public consultation on the Future Fuel Mix for Electricity Generation for Hong Kong. Having regard to the Government's energy policy objectives and various relevant considerations, two fuel mix options were put forward for public consultation and Members' views on the options were solicited.

(2) <u>Meeting on 24 October 2014</u>

(a) <u>Background briefings by the two power companies</u>

Following the appointment of Members to the EnAC on 15 July 2014, the two power companies, viz. CLP Power Hong Kong Limited (CLP) and The Hongkong Electric Company Limited (HEC), provided Members with background briefings on their business activities.

(b) <u>Membership of the Energy Efficiency and Conservation</u> <u>Sub-committee</u>

The Committee endorsed the proposed membership of the Energy Efficiency and Conservation Sub-committee and the nomination for Mr Stanley WONG Yuen-fai to continue to serve as the Chairman of the Sub-committee.

(3) <u>Meeting on 16 December 2014</u>

Electricity Tariff for 2015

- (a) <u>Presentation by HEC</u>
- (b) <u>Presentation by CLP</u>

Members discussed the two power companies' tariff proposals for 2015, which would be presented to the LegCo Panel on Economic Development on the same day. CLP proposed a 3.1% increase on its average net tariff for 2015 while HEC would freeze its tariffs.

IV. <u>Major Activities of the Energy Efficiency and Conservation</u> <u>Sub-committee during the period from 1 January to 31 December</u> <u>2014</u>

The Energy Efficiency and Conservation Sub-committee (EE&C) was set up under the EnAC to consider proposals to promote energy efficiency and conservation in Hong Kong, having regard to their technical merits, potential effectiveness and environmental, economic and social implications.

Meeting on 23 January 2014

(a) <u>Review of the grading standard under the Mandatory Energy</u> <u>Efficiency Labelling Scheme</u>

Members were briefed on the background of the Mandatory Energy Efficiency Labelling Scheme and the proposed upgrading energy efficiency standards for refrigerating appliances, washing machines and air conditioners.

(b) <u>Update on Full Operation of the Buildings Energy Efficiency</u> <u>Ordinance, Cap. 610</u>

Members were briefed on the operation of the Buildings Energy Efficiency Ordinance since the Ordinance came into operation in September 2012.
