Item 3 – Update on the Education and Publicity Programmes and the Launching of E-Learning Platform on Decarbonisation (EPSC Paper No. 01/21)

Members noted the progress of the E-learning Platform and the on-going education and publicity programmes as set out in the paper.

E-Learning Platform

Members discussed and welcomed the launching of the E-Learning Platform later this year as set out in the paper. The Secretariat would explore the extension of the Platform to junior forms of secondary schools and primary schools and update the Platform as appropriate.

Ongoing Education and Publicity Programmes

Regarding the School Outreach Programme (“SOP”), Members supported the recommendation for formal extension of workshop with field trip and drama to primary schools under SOP from 2021/22 onward as set out in the paper.

Members also discussed about other programmes and it was suggested that priority should be given to “innovation” in selection of the Outstanding Performance Award in the 2020/22 School Award Programme and collaboration with the Hong Kong Association of Property Management Companies should be explored to further promote sustainable development in residential estates.

There was no other business to be discussed at the meeting. The Secretary thanked all Members for their support in the term and was looking forward to continuous collaboration afterwards.
